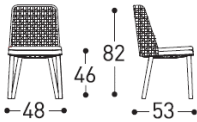

STRUCTURAL COMPONENTS

LEGS IN IROKO WOOD/ALUMINIUM, SEAT IN FABRIC AND BACKREST VAR#ROPE OR UPHOLSTERY.

SEAT: QUICK DRY POLYURETHANE PADDING IN SEVERAL DENSITIES + RESIN POLYESTER FIBER, WITH OUTSIDE TOP MESH IN POLYESTER AND OUTSIDE BOTTOM MESH IN POLYPROPYLENE. REMOVABLE CUSHION COVER

BACK (UPHOLSTERY VERSION): QUICK DRY POLYURETHANE PADDING IN SEVERAL DENSITIES + RESINATED POLYESTER FIBER. CUSHION COVER REMOVABLE.
